If SLP is selected and paid for, Enterprise provides the renter and authorized drivers with third party liability protection in an amount equal to the minimum financial responsibility limits applicable to the vehicle (the Primary Protection). SLP also provides third party liability protection, through an excess liability policy, with limits of the difference between the Primary Protection and a combined single limit of \$1million per accident for bodily injury, death and/or property damage to others arising out of the use or operation of the Enterprise rental vehicle by the renter or an authorized driver, subject to the terms and conditions of the policy. SLP also provides Uninsured and Underinsured Motorist (collectively UM/UIM) for bodily injury and property damage in an amount equal to the minimum financial responsibility limits applicable to the vehicle (the Primary Protection). SLP also provides UM/UIM for the difference between the Primary Protection and \$100,000.
